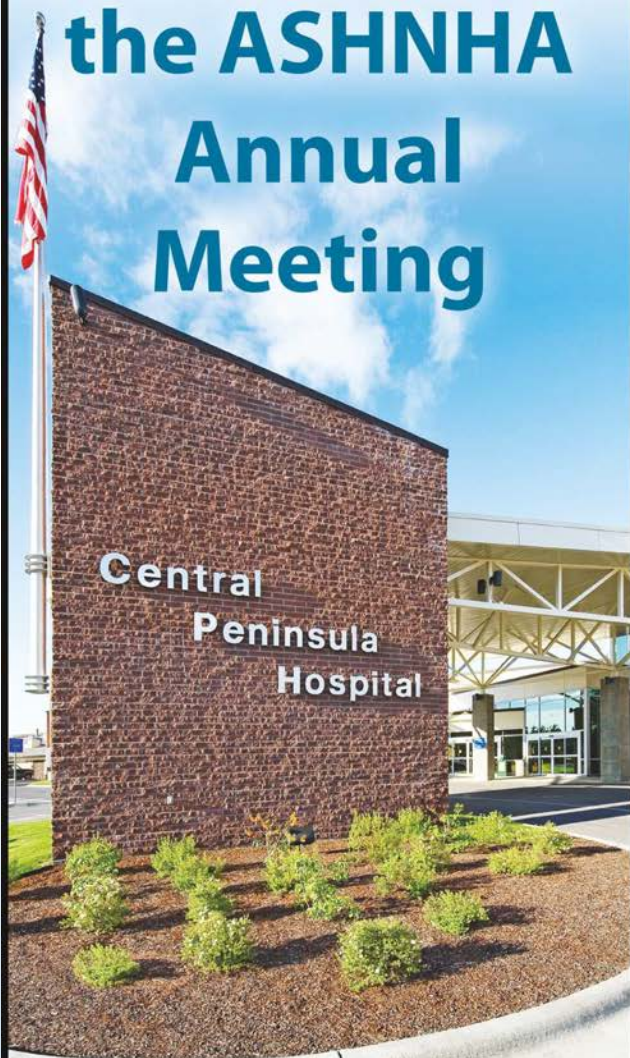

Speakers

Paul Keckley, PhD

Paul Keckley is managing editor of The Keckley Report, a healthcare researcher and widely-known industry expert. He writes a regular column for Hospitals & Health Networks and has published three books.



Keckley served as managing director of the Navigant Center for Healthcare Research and Policy Analysis (2014-2015), executive director of the Deloitte Center for Health Solutions (2006-2013), in executive administration at Vanderbilt University Medical Center (1998-2006), and as Chief Executive Officer of PhyCor Management Corporation-the IPA Subsidiary of PhyCor Inc. (1994-1998). He also served as an Adjunct Professor in the Schools of Medicine, Business and Health Policy at Georgetown University and Vanderbilt University.

Josh Stivers, MHA

Josh Stivers has over 20 years of police and security background. He currently serves as the security manager for Swedish Medical Center Seattle, First Hill and Cherry Hill Campuses, and he oversees the security guard training of over 70 officers.



Stivers co-chairs the Swedish Medical Center workplace violence committee and is considered a leading expert in active shooter response training and is a national instructor on how to “be safe” during these types of events. Stivers earned his Master’s Degree in Healthcare Administration in 2015, has degrees in Criminal Justice and Public Administration, and has earned his CPD (Crime Prevention through Environmental Design) designation.



Joe Fifer, FHFMA, CPA

Fifer is president and CEO of the Healthcare Financial Management Association (HFMA). HFMA provides the resources healthcare organizations need to

achieve sound fiscal health to provide excellent patient care. An HFMA member since 1983, Fifer has served as a chapter president and HFMA board member. He was Chair of the HFMA Board of Directors in 2006-07. In 2016, Joe was named to Modern Healthcare's list of the 100 Most Influential People in Healthcare for the second time.

Prior to assuming his position with HFMA, Fifer was vice president of hospital finance at Spectrum Health, and McLaren Health Care Corporation. He was senior vice president of finance and CFO at Ingham Regional Medical Center. He began his career at Ernst & Young.

Clifton Porter II

Clifton (Clif) Porter, II is the senior vice president of government relations at the American Health Care Association (AHCA) and the National Center for Assisted Living (NCAL). He serves as the top lobbyist in AHCA/NCAL and works to promote the association's legislative agenda. He continues to advocate against cuts to Medicare and Medicaid, and backs policies that rationalize health care payments in a way that aligns payments with patients' needs vs. site of service. Porter also supports legislation that would have observation stays count towards a patient's skilled nursing Medicare benefits, along with several other policy initiatives.



Porter has been serving the needs of seniors in the long-term care field for over 25 years. He began his career as an Administrator-in-training at a skilled nursing facility in 1989 and served as Assistant Administrator and Administrator of

several skilled nursing centers. Porter led HCR ManorCare's Government Relations Department from 2004-2013.

Porter received his Bachelor of Science Degree from the Medical College of Virginia, Virginia Commonwealth University in 1989, majoring in Healthcare Management.

Gary Roth

Gary L. Roth, DO, FACOS, FCCM, FACS, is the chief medical officer for the Michigan Health & Hospital Association and is board certified in cardiothoracic surgery, peripheral vascular surgery and surgical critical care.



He received his medical degree at the Kirksville (MO) College of Osteopathic Medicine in 1981. Roth currently is on the medical staff at Sparrow Hospital, Lansing, where he continues to care for patients. He is a fellow in

Jay Butler, MD

Jay Butler was appointed chief medical officer for the Alaska Department of Health and Social Services and director of the Division of Public Health by Governor Bill Walker in December 2014. He is a graduate of the University of North Carolina Medical School, has completed clinical trainings at Vanderbilt and Emory Universities, and maintains clinical board certifications in infectious diseases, internal medicine, and pediatrics.



He has authored or co-authored over 100 scientific papers and medical textbook chapters on infectious diseases and emergency preparedness, and he is an affiliate professor of medicine at the University of Alaska Anchorage.

Butler was senior director for community health services at the Alaska Native Tribal Health Consortium in Anchorage, where he was also a clinical infectious diseases consultant and medical director for infection control and employee health. Earlier work includes serving as chief medical officer of the Alaska Department of Health Social Services, Alaska state epidemiologist, director of CDC's Arctic Investigations Program, and medical epidemiologist in CDC's National Center for Infectious Diseases in Atlanta.
