WE PROVIDE OVER 40 LEARNING SESSIONS TO ATTENDEES COVERING ALL ASPECTS OF WEED MANAGEMENT. WE HAVE OVER 300 ATTENDEES. THIS TRAINING WAS CERTIFIED FOR UP TO SIX COMMERCIAL AND FIVE PRIVATE PESTICIDE CREDITS. THREE REGIONAL WEED MANAGER TRAININGS: WEH HELD TWO SPRING AND ONE FALL TRAINING. THIS WAS OPEN TO THE PUBLIC, AND THE TOPICS WERE FOCUSED ON THE PERSON WHO WEED MANAGEMENT WAS A KEY ELEMENT OF THEIR JOB. THESE TRAININGS INCLUDE ALL ASPECTS OF WEED MANAGEMENT. THESE TRAININGS WERE APPROVED FOR COMMERCIAL PESTICIDE RECERTIFICATION CREDITS.
