SOZO SUCCESSFULLY LAUNCHED THE OPENING OF AN ORPHANAGE IN UGANDA, AFRICA TO SERVE THE NEEDS OF AT-RISK CHILDREN. THE ORPHANAGE PROVIDES FOOD, CLOTHING, SHELTER, MEDICAL CARE AND EDUCATION TO CHILDREN. A TOTAL OF 34 CHILDREN WERE SERVED IN-HOUSE IN 2011. THE CHILDREN SERVED ARE FROM VERY POOR COMMUNITIES AND HAVE NO PARENT FIGURE IN THEIR LIVES. AT THE END OF 2013, SOZO'S FAMILY HAD GROWN TO 78 CHILDREN IN HOMES AND ANOTHER 36 CHILDREN OUTSIDE OF HOMES. THE 78 CHILDREN ARE RAISED IN HOMES, NOT INSTITUTIONS, AND ALL NEEDS ARE MET.
